NOW, THEREFORE, it is hereby understood and agreed:

--The **Supplier** shall furnish, subject to the limitations set out in the rules and regulations and ordinances, such quantity of water, as the **User** may need in connection with their occupancy.

--The **User** this date agrees to make a deposit of \$ 100 The deposit shall be held and applied by the **Supplier** to the payment of the account of the **User** should service to the User be terminated, either voluntarily by **User**, or involuntarily by the **Supplier**; and the balance of the account shall remain unpaid. Should the account be fully paid at the time of the termination of service to the **User**, the deposit shall be returned by the **Supplier** within a reasonable time thereafter.

--The **User** pays this date a \$ 50 (waived for new meter set) connection fee which is NOT refundable.

--New Meter Set paid by **User** \$1,200.00 (if applicable).

--The **User** agrees to pay a 10% late fee if their water bill is not paid by the due date EACH month, subject to disconnection if not paid.

--**River Road Water has the right to turn off water service once the water bill becomes thirty (30) days past due. If the water is cut off for non-payment of the bill, the User agrees to pay a \$100 reconnection fee plus the entire account balance to date.**
